The adoptions of Tucker and Booth are not included in this list. This list includes only those veterans who were interred on Confederate Hill. Neither Tucker nor Booth were interred within the confines of the curbing surrounding Confederate Hill. Due to our prior agreement with Loudon Park, no more veterans outside the curbing of Confederate Hill can be adopted through the Adopt a Confederate Program.

The number of markers purchased will not agree with the number of veterans adopted. This is because one of the stones recognizes 9 UNKNOWN veterans and a second stone recognizes 4 UNKNOWN veterans. As a result, the number of stones purchased will always be 11 less than the "Total Veterans Adopted" as indicated above.
